This volume contains the texts of written pleadings, the minutes of public sittings and other documents from the prompt release proceedings in the M/V "SAIGA" case (Saint Vincent and the Grenadines v. Guinea) in their original language. The Orders and Judgment made in this case have been published in Reports of Judgments, Advisory Opinions and Orders 1997 (ITLOS Reports 1997).
